Aedifica invests €18 million in the development of 4 care properties in Finland

- Development of a service community, a care home and two residential care centres for disabled people in Finland
 - Total investment: approx. €18 million
 - Average gross yield: approx. 6%
 - Total capacity: 116 residents & 75 children
 - Diversified tenant pool of experienced private and non-profit operators

Stefaan Gielens, CEO of Aedifica, commented: "Aedifica continues to expand its Finnish healthcare real estate portfolio by investing approx. €18 million in the development of four care properties. Upon completion of the works, the buildings will welcome up to 116 residents and 75 children. We look forward to continuing to develop futureproof healthcare real estate with our Finnish Hoivatilat team, which designed and developed all projects."

Atte Nittylä, CEO of Hoivatilat, adding: "We will develop a service community in Espoo, a care home in Kuopio and two residential care centres for disabled people in Nokia and Sotkamo. In the design of these new development projects, we paid special attention to environmental standards and energy efficiency. Together we are creating a better society."

The Finnish Hoivatilat team will develop a service community in Espoo (272,000 inhabitants). The **Espoo Kuurinkallio** service community will include a child day-care centre welcoming up to 75 children on a daily basis and a residential care centre accommodating 26 disabled people. Construction works have already started and are expected to be completed in the second quarter of 2024. The child day-care centre will be operated by Pilke, a Finnish operator that offers innovative early childhood education and care services to over 10,000 children in 180 child day-care centres across Finland, employing approx. 2,000 staff. Pilke already operates 25 Aedifica sites. The residential care centre will be operated by Humana Finland, a leading Nordic care company that offers individual and family care services, personal assistance, elderly care and special services housing. Humana Finland currently already operates 15 care homes for disabled people in Finland.

In Kuopio (118,000 inhabitants), the team will develop a care home. **Kuopio Torpankatu** will accommodate 47 elderly people requiring continuous care. Construction works have already started and are expected to be completed in the first quarter of 2024. The building will be operated by Esperi, a private player with 20 years of experience in the healthcare sector, employing 6,800 staff in approx. 200 municipalities across Finland. Esperi provides a wide range of healthcare services to different target groups. The group already operates 4 Aedifica properties.

In addition, Hoivatilat will develop a residential care centre for disabled people in Nokia (35,000 inhabitants). **Nokia Tähtisumunkatu** will welcome up to 21 residents. Construction works have already started are expected to be completed in the fourth quarter of 2023. The building will be operated by HDL (Helsingin Diakonissalaitos), a non-profit organisation. The 155-year-old foundation provides social welfare and health services for people in need of special support. HDL employs 3,200 people and already operates 3 Aedifica properties.

In Sotkamo (10,000 inhabitants), the team will develop a residential care centre for disabled people. **Sotkamo Härkökivenkatu** will welcome up to 22 residents. Construction works will start in the second quarter of 2023 and are expected to be completed in the first quarter of 2024. This building will also be operated by Esperi.

The four care properties will use energy-efficient systems, such as geothermal heating and an air-water heat pump which should result in an EPC¹ rating 'A' or 'B' for each of these buildings, contributing to the continued improvement of the sustainability of the Group's real estate portfolio.
